

Have you heard about Project 2025?

On the state of America today:

“Look at America under the ruling and cultural elite today ... Children suffer the toxic normalization of transgenderism with drag queens and pornography invading their school libraries.” —*p. 1*

On what makes a good society:

“These are the mediating institutions that serve as the building blocks of any healthy society. Marriage. Family. Work. Church. School. Volunteering.” —*p. 3*

“Families comprised of a married mother, father, and their children are the foundation of a well-ordered nation and healthy society. ... The male–female dyad is essential to human nature and ... every child has a right to a mother and father.” — *p. 451 and 461*

On waging a culture war:

“The next conservative President must make the institutions of American civil society hard targets for woke culture warriors. This starts with deleting the terms sexual orientation and gender identity (‘SOGI’), diversity, equity, and inclusion (‘DEI’), gender, gender equality, gender equity, gender awareness, gender-sensitive, abortion, reproductive health, reproductive rights, and any other term used to deprive Americans of their First Amendment rights out of every federal rule, agency regulation, contract, grant, regulation, and piece of legislation that exists.” —*p. 4-5*

On mask and vaccine mandates:

“Whether it be mask and vaccine mandates, school and business closures, efforts to keep Americans from driving gas cars or using gas stoves, or efforts to defund the police, indoctrinate schoolchildren, alter beloved books, abridge free speech, undermine the colorblind ideal, or deny the biological reality that there are only two sexes, the Left’s steady stream of insanity appears to be never-ending. ... “[Centers for Medicare] should ... refrain from imposing general COVID-19 mask mandates on health care facilities or personnel.” —*p. 19 and 475*

“[The administrative state] must rein in agencies such as the Occupational Safety and Health Administration, which the Biden Administration weaponized to attempt to force COVID-19 vaccine mandates on 84 million Americans through their workplaces.” —*p. 886*

On undoing Biden’s progress on climate change and racial justice:

“The next Administration will face a significant challenge in unwinding policies and procedures that are used to advance radical gender, racial, and equity initiatives under the banner of science. Similarly, the Biden Administration’s climate fanaticism will need a whole-of-government unwinding.” —*p. 60*

On trans soldiers in the military:

“Reverse policies that allow transgender individuals to serve in the military. Gender dysphoria is incompatible with the demands of military service, and the use of public monies for transgender surgeries or to facilitate abortion for service members should be ended.” —*p. 104*

On government aid for abortion:

“The U.S. government should not and cannot promote or fund abortion in international programs or multilateral organizations.” —*p. 192*

“The Secretary must ensure that all HHS (Health and Human Services) programs and activities are rooted in a deep respect for innocent human life from day one until natural death: Abortion and euthanasia are not health care.” — *p. 450*

“The Office of the Secretary should eliminate the HHS Reproductive Healthcare Access Task Force and install a pro-life task force to ensure that all of the department’s divisions seek to use their authority to promote the life and health of women and their unborn children.” —p. 489

On public radio and TV:

“All Republican Presidents have recognized that public funding of domestic broadcasts is a mistake. ... Conservatives will thus reward a President who eliminates this tyrannical situation. PBS and NPR do not even bother to run programming that would attract conservatives.” —p. 246-247

On student loan forgiveness:

“Borrowers should be expected to repay their loans. ... The new Administration must end the prior Administration’s abuse of the agency’s payment pause and HEA loan forgiveness programs, including borrower defense to repayment, closed school discharge, and Public Service Loan Forgiveness.” —p. 322 and 340

On environmental policy:

“Climate-change research should be disbanded. ... The National Oceanic and Atmospheric Administration (NOAA) should be broken up and downsized. ... [The Office of Air and Radiation] ... is the source of much of NOAA’s climate alarmism.” —p. 675-676

On IVF and embryonic research:

“There is never any justification for ending a child’s life as part of research, and the research benefits from splicing or growing aborted fetal cells and aborted baby body parts can easily be provided by alternative sources. All research should be prohibited as a matter of law and policy. ... Research using human embryonic stem cells also involves the destruction of human life and should not be subsidized with taxpayer dollars.” —p. 455 and 460

On who should be allowed to get married and have children:

“Married men and women are the ideal, natural family structure because all children have a right to be raised by the men and women who conceived them.” —p. 489

On the Comstock Act and the availability of mifepristone:

“The FDA is statutorily charged with guaranteeing the safety and efficacy of drugs and therefore should withdraw this drug [abortion pills] that is proven to be dangerous to women and by definition fatally unsafe for unborn children. ... Stop promoting or approving mail-order abortions in violation of long-standing federal laws that prohibit the mailing and interstate carriage of abortion drugs.” —p. 458

On the federal death penalty:

“Enforce the death penalty where appropriate and applicable ... until Congress says otherwise through legislation.” —p. 554

On child labor:

“With parental consent and proper training, certain young adults should be allowed to learn and work in more dangerous occupations.” —p. 595

On eliminating the U.S. central banking system:

“The next Administration should think about proposing legislation that would ‘effectively abolish’ the Federal Reserve and replace it with ‘free banking.’” —p. 661

On the next census:

“The Census Bureau National Advisory Committee on Racial, Ethnic, and Other Populations (NAC) was established by the Obama Administration in 2012 and rechartered by the Biden Administration in 2022. The committee is a hotbed for left-wing activists intent upon injecting racial and social-justice theory into the governing philosophy of the Census Bureau. The NAC should immediately be abolished by the incoming Administration.” —p. 682
